Lennar Corporation Increases Annual Dividend to \$1.00 Per Share

The dividend is payable on October 30, 2020 to holders of record at the close of business on October 16, 2020.

Stuart Miller, Executive Chairman of Lennar, said, "We are increasing our dividend as part of our overall strategy of focusing on total shareholder returns. Given our confidence in our operating platform and resulting cash flow generation, we believe a diversified program of debt reduction, stock repurchase and now an increased dividend, is appropriate."
